- B. San Ramon Valley Fire Protection District, Derek Krause, Deputy Chief
 - Station 32 UPDATE: The District continues to move ahead with development plans of the fire station. They will be using a Construction Manager At-Risk builder to help with liability and cost. RFP/RFQ for service to go out soon. Loo to begin construction I December 2015 or January 2016.

- B. Variance Permit application #VR15-1029 The applicant requests approval of a variance to allow for an 8 foot side yard (where 15 feet is required) and an 18 foot, 9 inch aggregate side yard (where 35 feet is required) for the reconstruction of an existing deck and a second floor balcony. This application includes a Tree Permit request to work within the drip line of three code-protected trees. The subject property is located at 312 Castle Crest in Alamo.

- C. Minor Subdivision application #MS15-0002 and Rezoning application #RZ15-3229 The applicant requests approval of a tentative map to subdivide two parcels (totaling 2.41 acres) into four parcels. Concurrently, the applicant requests approval of a rezoning of the property from A-2. General Agriculture (5-acre minimum lot size) to -20, Single Family Residential (20,000 square foot minimum lot size). The application requests to remove 53 trees. The property is located at 20 Alamo Glen Trail in Alamo.
